TERMS & CONDITIONS

1. TechMentor (herein called the "Show") is owned and operated by 1105 Media (herein called the "Management").
2. If Exhibitor desires to cancel this Agreement, notification must be made in writing by the Exhibitor and confirmed by Management. If such notice is received by the Management on or before 180 days prior to the first day of the show, 50% of the total fee shall be due Management. If notice is received after that date (less than 180 days until the start of the show) 100% of the total fee is due Management. If any sponsorship or advertising services are provided by the Management prior to notification of cancellation, regardless of timeframe, 100% of the total fee is due Management. If Exhibitor cancels participation in the Show, this agreement will be cancelled and the exhibitor will be liable for payment as outlined above.
3. Priority Points are assigned for sponsorship and advertising at the sole discretion of the Management. If Exhibitor cancels this agreement, Priority Points assigned for sponsorship or advertising are forfeited regardless of payments received by Management.
4. All Sponsorship and Advertising opportunities are subject to approval by Management. Management reserves the right to restrict promotions which, because of noise, method of operation, materials or for any other reason become objectionable, and also to prohibit or to remove any promotion

5. which, in its opinion, may detract from the general character of the Show. This reservation includes persons, things, conduct, printed matter and anything of character which Management determines is objectionable. In the event of such restriction or removal, Management shall not be liable for any refunds or other promotion expenses.
5. Exhibitor shall be responsible for providing the "finished" Sponsorship and/or Advertising material by the deadline date and for meeting the exact specifications indicated, as provided by Management. In the event that such deadline is not met by the Exhibitor, the space and/or opportunity in question shall revert back to Management without any obligation to refund monies.
6. Management is not liable to delays in delivery and/or non-delivery as the result of an Act of God, action by any government or quasi-government entity, fire, flood, insurrection, riot, explosion, embargo, strikes whether legal or illegal, labor or material shortage, transportation interruption of any kind, work slowdown, or any other condition beyond the reasonable control of Management affecting the production or delivery in any manner.
7. Under no circumstances will Management be liable for loss of profits or other incidental or consequential damages for any of its acts or omissions whatsoever whether or not appraised with the possibility or likelihood of such lost profits or damages.
