

Call for Nominations

Nominations Due: August 4, 2006

ELIGIBILITY

- Nominations are open to all tech sectors.
- Selection is based on percentage growth of government revenue over a period of five years. This includes all prime and subcontracting revenue from federal, state and local contracts. Technology service providers, product resellers, product manufacturers and systems integrators are eligible
- Revenue must be a minimum of \$100,000 in the first year.
- Applicants must be located in Greater D.C. area or have government sales office there.
- Company must meet the government criteria for small business or be a member of the 8(a) program (To see if your company is a small business, visit <u>SBAgov</u>.).

REQUIRED ATTACHMENTS

- Brief company history (200 words or less)
- Describe your areas of business and IT expertise (100 words or less)
- Major government customers
- List one or two major government contracts, including the value of the contract, the customer, when the contract was awarded and what services are being conducted
- Name of Chairman, CEO and President
- Certification letter by an independent accountant supporting the company's statement of revenues
- Nomination form must be signed to be valid, or if e-mailed, sent from the company ŒO's e-mail address
